Government Members:

CLASS I A governmental unit or department thereof engaged in the administration or formulation of laws and

ordinances relating to building construction and having the legal authority to interpret and enforce the

California Code of Regulations.

CLASS II An individual actively engaged in, but not limited to, the checking of plans or the inspection of buildings,

plumbing/electrical facilities within buildings under construction and employed by a governmental unit or

department which enforces laws or ordinances relating to building construction.

PROFESSIONAL: An individual actively engaged in, but not limited to, the checking of plans or the inspection of buildings,

plumbing/electrical facilities within buildings under construction, but who is not an employee of a

governmental unit or department

ASSOCIATE: An individual, company, corporation, or association actively engaged in the building construction or allied

industry.

HONORARY An individual, form or association who has rendered outstanding and meritorious services in furtherance of

the objective of the Foothill Chapter and who shall be proposed by the Executive Board and confirmed by

Majority vote at a regular business meeting.

RETIRED Retired individuals previously employed by a governmental agency as inspectors of building, electrical or

mechanical components; as Building Officials, plan checkers, or in a related capacity involving the

administration or enforcement of codes related to building construction.
